### Terms and Conditions – Rakaz Al Joudah General Contracting (RJC)

#### Terminology

- **Owner:** Refers to RJC and its duly authorized and appointed representatives.
- **Hirer:** Any person or company accepting a quotation, contract, or equipment delivery from RJC.
- **The Agreement:** The legally binding hire agreement governed by these Terms.
- **Site:** The delivery address for the equipment.
- **Region:** Saudi Arabia.
- **Equipment:** Includes AWP, MEWP, cranes, vehicles, accessories, etc., subject to availability.
- **Force Majeure:** Events beyond a party's control (e.g., war, pandemics, natural disasters, etc.).

#### Commercial Terms

- **Payment Terms:** 100% advance unless otherwise approved.
- **Currency:** Saudi Riyals (SAR).
- **Tax:** All rates exclude VAT or applicable taxes.
- **Mobilization/Demobilization:** Responsibility of the client.

#### Hire Terms

##### Start & End:

- **a.** If transported by Hirer: Hire starts when equipment leaves RJC and ends upon return (Sat–Thu, 7:00 AM–6:00 PM).
- **b.** If transported by RJC: Hire starts on-site arrival and ends when received at RJC (Sat–Thu, 7:00 AM–6:00 PM).
- **c.** Early returns may still be charged in full.

##### Minimum Hours:

- Daily: 10 hours minimum
- Weekly: 60 hours (6 days × 10 hours)
- Monthly: 260 hours (26 days × 10 hours)
- Extra hours are charged pro-rata.

## Pricing Includes:

- Standard equipment configuration
- Valid third-party test certificates

## Pricing Excludes:

- Operator, fuel, oil, maintenance, tire punctures, repairs, permits, or security passes

## Other Conditions

- Extensions must be confirmed before the end of the month.
- Off-hire notice must be emailed before 6:00 PM (Sat–Thu).
- Breakdowns due to misuse or operator error are chargeable.
- Hirer is responsible for all damage including during transit.
- Hirer must provide “all-risk” insurance coverage.
- RJC branding must not be removed or obscured.
- Operator must be certified and use proper PPE.
- If transporting the equipment, the Hirer must use licensed drivers and roadworthy vehicles.
- No discounts apply for public holidays, Ramadan, or bad weather.
- Late payments may result in equipment shutdown while hire charges continue; legal action may follow.

## Legal Terms

- Governing law: Saudi law. Disputes are resolved amicably or via court after 15-day notice.
- Any representative signing at delivery is deemed authorized and legally binding.
- Quotation valid for 14 days.
- Contract is non-transferable without RJC’s written approval.
- All equipment remains the property of RJC.
- Alterations are only valid if mutually agreed in writing.
